Based on article 71, paragraph 2, indent 4 and Article 104, paragraph 2 of the Law on Higher Education ("Official Journal of the Republic of Macedonia" no. 35/08, 103/8, 26/9, 83/09, 99/09, 115/10, 17/11 and 51/11), the Accreditation and Evaluation Board on the 8th session, held on 29.03.2012, adopted the following

DECISION

accrediting the elaborate for organising the second cycle of masters studies – cultural studies at the Institute for Social Sciences and Humanities – Skopje

1. The elaborate for organising a second cycle of masters studies – cultural studies of the Institute for Social Science and Humanities – Skopje, in accordance with the Classification of Research Areas, Fields and subjects in accordance with the international Frascati classification, attached as Annex 1 to the Regulation on Normatives and Standards for Establishing higher education institutions and for performing higher education activities (Official Journal of the Republic of Macedonia no. 103/10, 168/10 and 10/11).
2. The accreditation from point 1 of this Decision is granted for the one year (two semesters) MA study programme in Gender Studies of the Institute for Social Sciences and Humanities – Skopje.
3. After the completed studies of the second cycle, the student acquires 60 ECTS and the academic title Master in Cultural Studies, research area: Interdisciplinary studies, Social Sciences and Humanities, research fields: Anthropology, Sociology, Philosophy and Political Sciences.
4. This decision enters into force on the day it is adopted.

ELABORATION

In order to receive consent to organise a second cycle of studies (academic), the Institute of Social Sciences and Humanities of the Private Research Institute "Institute of Social Sciences and Humanities" Skopje – Skopje, submitted an Elaborate for Accreditation of the Curriculum no. 17 – 160/1 from 23.03.2012 to the Higher Education Accreditation and Evaluation Board for acceptance and accreditation of the cultural studies study programme.

On the inter-session 7/8 the Accreditation Board formed an expert committee and on the 8th session held on 29.03.2012, based on the submitted elaborate and the Expert Committee Report, it decided as in the dispositive of this Decision.
