Based on article 71, paragraph 2, indent 4 and Article 104, paragraph 2 of the Law on Higher Education ("Official Journal of the Republic of Macedonia" no. 35/08, 103/8, 26/9, 83/09, 99/09, 115/10, 17/11, 51/11, 123/12, 15/13 and 24/13), the Accreditation and Evaluation Board on the 21<sup>st</sup> session, held on 28.06.2013, adopted the following

#### DECISION

For accreditation of the new study programme – policy studies, second cycle of one-year studies at the Institute for Social Sciences and Humanities – Skopje

1. The new study programme – policy studies, second cycle of one-year studies at the Institute of Social Sciences and Humanities – Skopje, in accordance with the Classification of Research Areas, Fields and subjects in accordance with the international Frascati classification, attached as Annex 1 to the Regulation on Normatives and Standards for Establishing higher education institutions and for performing higher education activities ("Official Journal of the Republic of Macedonia" no. 103/10, 168/10 and 10/11).
2. The duration of the study programme from point 1 of this Decision is one year (two semesters).
3. After the completed studies of the study programme from point 1 of this Decision, the student acquires 60 ECTS and the academic title Master in Policy Studies, research area: Social Sciences and Humanities, research field: policy studies are an interdisciplinary area. The interdisciplinary nature encompasses at the same time several fields: Sociology – with its culturological aspects, political economy, international relations studies, development studies, gender studies, philosophy and social psychology, research field: Policy Studies.
4. This decision enters into force on the day it is adopted.

#### ELABORATION

Based on the previously adopted decision of the Science Board of the Institute of Social Sciences and Humanities – Skopje for organising a one-year study programme "Policy Studies", the Institute of Social Sciences and Humanities – Skopje submitted a proposal for accepting the accreditation elaborate for the subject study programme on 22.05.2013 to the Higher Education Accreditation and Evaluation Board in the Republic of Macedonia for acceptance and accreditation of the cultural studies study programme.
